CALL THE MEETING TO ORDER

Kenn Tuckey welcomed everyone and called the meeting to order.

MINUTES

On a motion by George Tyson, seconded by Charles Wilson, the Board accepted the minutes of the June 12, 2024, meeting. Passed by majority vote.

TREASURER'S REPORT
