#### Crafting a Compelling Need Statement



Define

Clearly define the problem



Support

Support with data: demographics, studies, testimonials





Describe

Describe the urgency for your project



Connect

Connect to agency priorities



#### Need Statement Example

Before: "Our community needs more outdoor recreation spaces."

• After: "Over 8,000 residents in our township lack access to safe, walkable outdoor spaces. The nearest public park is over 3 miles away, and 42% of households do not have access to a vehicle. Since 2020, local demand for trails and green spaces has increased by 65%, yet our current infrastructure is outdated and insufficient. This project will create a new multi-use trail connecting three neighborhoods to the regional park system, directly addressing mobility, health, and equity gaps identified in the county's recreation plan."

#### Impact Statement Examples

- "This trail will help people get outside more and enjoy nature."
- "The new trail will connect neighborhoods to the park system and encourage more outdoor activity. It will reduce car trips and promote healthier lifestyles."
- "The construction of a 2.5-mile multi-use trail will connect over 2,000 residents, primarily youth and seniors, from three underserved neighborhoods to the regional park system. We anticipate a 40% increase in trail usage and a 25% reduction in vehicle trips for local recreation. The trail will also support environmental education programs for local schools and serve as a catalyst for future green infrastructure investments, aligning with the county's sustainability and equity goals."

#### Bonus Tip: Using Al in Grant Writing

#### Examples of how AI can help you write grants:

- Drafting summaries or project descriptions based on bullet points
- Rewriting for clarity or tone (e.g., making language more funder friendly)
- Creating checklist or templates for grant planning
- Brainstorming outcomes or metrics for evaluation sections
- Formatting budgets or narratives based on your input

Al won't know your community like you do. It can't replace your relationships, your vision, your understanding of local needs. But when used thoughtfully, it can save time and help you focus on the parts of grant writing that require human insight.
